Janesville, Wisconsin  
November 13, 2018

The Rock County Board of Supervisors met, pursuant to adjournment on November 7, 2018, at 9:00 a.m. in the Courthouse at Janesville, Wisconsin.

Chair Podzilni called the meeting to order. Supervisor Mawhinney gave the invocation.

3. Roll Call.

At roll call, Supervisors Peer, Fell, Aegerter, Beaver, Mawhinney, Fox, Richard, Driscoll, Bussie, Davis, Thomas, Knudson, Rynes, Brown, Rashkin, Gramke, Pleasant, Brill, Schulz, Zajac, Bostwick, Sweeney, Hawes, Brien and Podzilni were present. Supervisors Potter, Gustina, Yeomans and Owens were absent. PRESENT – 25. ABSENT – 4.

7. Citizen Participation, Communications and Announcements

Robert Harlow spoke on support for RSVP (Retired and Senior Volunteer Program) in the budget. Supervisor Bussie spoke on RSVP. Supervisor Mawhinney thanked all the people who came out to vote and the County Clerk for an excellent job.

11.A. Annual Report by County Clerk per Wis. Stats. 59.17(16)

The records for 2017 indicate the following: Total collections - \$331,114,596.74. Total Disbursements - \$320,564,847.83. Increase in cash balance of Equivalency - \$10,549,748.91.

11.B. Recommendations by Finance Committee for Revisions to the 2019 Recommended Budget  
Supervisor Mawhinney listed Finance Committee Recommendations.

- The Department of Public Works has requested their Accounting Supervisor to be reallocated from Range 20 to Range 21. They are also requesting a reallocation of the Cost Allocation Specialist positions from Range 3 to Range 1A and retitled to Accounting Specialist. These changes would be funded by a reduction in DPW's Software Purchase budget line, therefore no effect on the tax levy until 2020. The Committee voted 4 to 0 to approve these changes.
- The Department of Public Works has also requested funding a full 1.0 FTE Parks Community Coordinator position. The recommended budget includes funding for 0.4 FTE. The additional 0.6 FTE would be funded by ATC funds the County expects to receive in 2018. The Committee voted 4 to 0 to approve these changes.
- The recommended budget includes a reallocation of one of the Rock Haven Account Clerk III positions to Accounting Specialist. However, the funding was not included. Therefore, a \$1,359 addition to the wage and benefits line has been requested with a like decrease to the Laundry account. The Committee voted 4 to 0 to approve these changes.
- In the Human Services budget, funds were included for the reclassification of 6.0 FTE Case Manager I positions to Lead Workers. However, the budget comments only included 1.0 FTE. The Committee voted 4 to 0 to clarify the comments to the intended 6.0 FTEs.

12.C. Consideration and Adoption of Recommended 2019 Annual County Budget

Chair Podzilni called for the adoption of the 2019 recommended budget. Supervisors Mawhinney and Fox moved to adopt the Recommended 2019 Budget.

Supervisor Mawhinney and Fox moved to amend the 2019 budget to reallocate DPW's Accounting Supervisor from Range 20 to Range 21 and to reallocate the DPW Cost Allocation Specialists from Range 3 to Range 1A and retitled to Accounting Specialist. These changes would be funded by a decrease in DPW's software purchase line. Motion adopted by acclamation.

Supervisor Mawhinney and Zajac moved to amend the 2019 budget to increase the recommended 0.4 FTE Parks Community Coordinator to 1.0 FTE. The additional 0.6 FTE to be funded by ATC funds expected to be received in 2018. Motion adopted by acclamation.

Supervisor Mawhinney and Fox moved to amend the 2019 budget to include adding funds to the Rock Haven wage and benefit lines for the recommended reallocation of one of Rock Haven's Account Clerk III positions to an Accounting Specialist. This change would be funded by a decrease to Rock Haven's laundry account. Motion adopted by acclamation.

Supervisor Mawhinney and Zajac moved to clarify the County Administrator's Human Services comments to include 6.0 FTE reclassification of 6.0 FTE Case Manager I positions to Lead Workers, instead of the 1.0 FTE currently in the comments. Motion adopted by acclamation.

Supervisor Schulz and Brien moved to amend the 2019 budget to add \$20,000 to the budget for RSVP and to take the funds from the general fund. Supervisor Brien and Zajac moved to amend the budget change to take funds from the contingency fund instead of the general fund. Amendment to motion APPROVED on the following roll call vote: Supervisors Peer, Fell, Aegerter, Beaver, Mawhinney, Fox, Driscoll, Bussie, Davis, Thomas, Knudson, Rynes, Brown, Rashkin, Gramke, Pleasant, Schulz, Zajac,

Bostwick, Sweeney, Hawes and Brien voted in favor. Supervisors Richard, Brill and Podzilni voted against. Supervisors Potter, Gustina, Yeomans and Owens were absent.  
YES – 22. NO – 3. ABSENT – 4.

The amended motion to add \$20,000 to the budget for RSVP and to take the funds from the contingency fund APPROVED on the following roll call vote: Supervisors Peer, Fell, Aegerter, Driscoll, Bussie, Davis, Thomas, Knudson, Rynes, Brown, Rashkin, Gramke, Pleasant, Schulz, Zajac, Bostwick, Sweeney, Hawes and Brien voted in favor. Supervisors Beaver, Mawhinney, Fox, Richard and Podzilni voted against. Supervisor Brill abstained. Supervisors Potter, Gustina, Yeomans and Owens were absent.  
YES – 19. NO – 5. ABSTAIN – 1. ABSENT – 4.

Supervisor Mawhinney and Brien move to accept the amendments to the recommended budget.  
APPROVED by acclamation.

Supervisor Mawhinney and Fox motioned for County Board to recess for the Finance Committee to meet.  
Motion approved by acclamation at 10:07 a.m.

Chair Podzilni reconvened meeting at 10:14 a.m.

12.D. Setting the Tax Levy and Tax Rate for 2018 Resolution No. 18-11C-117  
NOW, THEREFORE, BE IT RESOLVED, that the sum of \$0 is hereby transferred from the General Fund to be applied against the proposed budget.

BE IT FURTHER RESOLVED that the detailed line items are not adopted but are for informational purposes only.

BE IT FURTHER RESOLVED that the state taxes and special charges as separately set out on the attached report in the amount of \$858, are hereby ratified.

BE IT FINALLY RESOLVED, that the line summary budget and personnel roster, as modified, are hereby adopted and that the resulting tax levy for 2018 be in the amount of \$67,635,689 which reflects a rate of \$6.196945 of equalized valuation.

Supervisors Mawhinney and Fox moved the above resolution. ADOPTED by acclamation.
