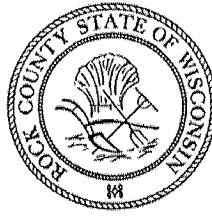

**IT IS ORDERED THAT:**

1. A recount be conducted of all the votes cast for the office of County Board Supervisor for District 4 at the Spring Election held on April 3, 2018 in the Town of Fulton Ward 4, Town of Harmony Ward 5, Town of Johnston all Wards, Lima all Wards, and Town of Milton all Wards.
2. The boards of canvassers convene at 9:00 a.m. on Friday, April 13, 2018 at:

3. The recount be completed by the board of canvassers immediately.
