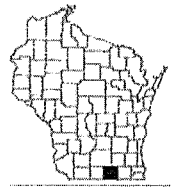

Executive Summary – Jon Boat

Funds are included in the 2019 budget for the purchase of one patrol boat to be used by the Rock County Sheriff's Office. Three quotes were solicited, and two dealers responded. Harbor Recreation, of Milton, Wisconsin, had the lower of the two quotes.

To better serve the citizens of Rock County, this boat will be used for, but not limited to, enforcement of state and local laws, search and rescue, and recovery of person(s). To accomplish this public service, the Sheriff's Office relies on specially equipped patrol boats to be ready in a moment's notice.

The Crestliner 2070 Retriever Jon Boat package will be largely reimbursed through the Wisconsin Department of Natural Resources Patrol Grant Program over the next five years.

The current Patrol Jon Boat was purchased in 2006, and is due for replacement. The current patrol boat will be traded towards the new Crestliner 2070 Retriever Jon Boat package. The trade in allowance, as quoted by Harbor Recreation of Milton, is \$3,000.00.

The Rock County Sheriff's Office and the Purchasing Manager reviewed the two submitted quotes and are recommending Harbor Recreation, of Milton, Wisconsin, as the lowest, quote at \$11,295.00 (after trade-in).
