BATTERMAN EMPLOYEE SEARCHED THEIR RECORDS AND WAS UNABLE TO FIND ANY EVIDENANCE OF THE CUT STONE BEING FOUND. FIELD NOTES INDICATES THE CI WAS PLACED ON LINE WITH THE SE & SW CORNERS OF SEC 3 AND PRORATED WITH RUGER'S DISTANCES.
