THIS POSITION IS NOW IN A PLOWED FARM FIELD. I FOUND THE LIMESTONE OF RECORD 1.2 DEEP AND PLACED A MAGNET ON THE SOUTH SIDE. I RESTORED THE CORNER THROUGH ACCEPTANCE OF FOUND EVIDENCE. IT APPEARS THAT BLEEDORN USED RUGER'S MEASUREMENTS TO PRORATE AGAINST THE ORIGINAL GOVERNMENT DISTANCES AND TO COMPUTE THE JOG DISTANCE. USING THIS METHOD PRODUCES A JOG OF 134.20 AND HE SHOWS A DISTANCE OF 133.48 WHICH IS WITHIN THE LEGAL TOLERANCE OF THE DAY.
