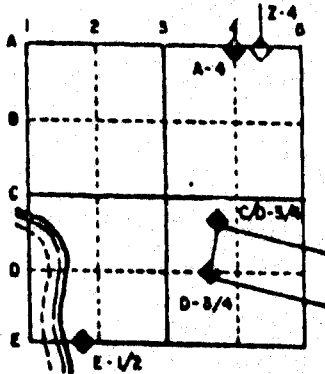

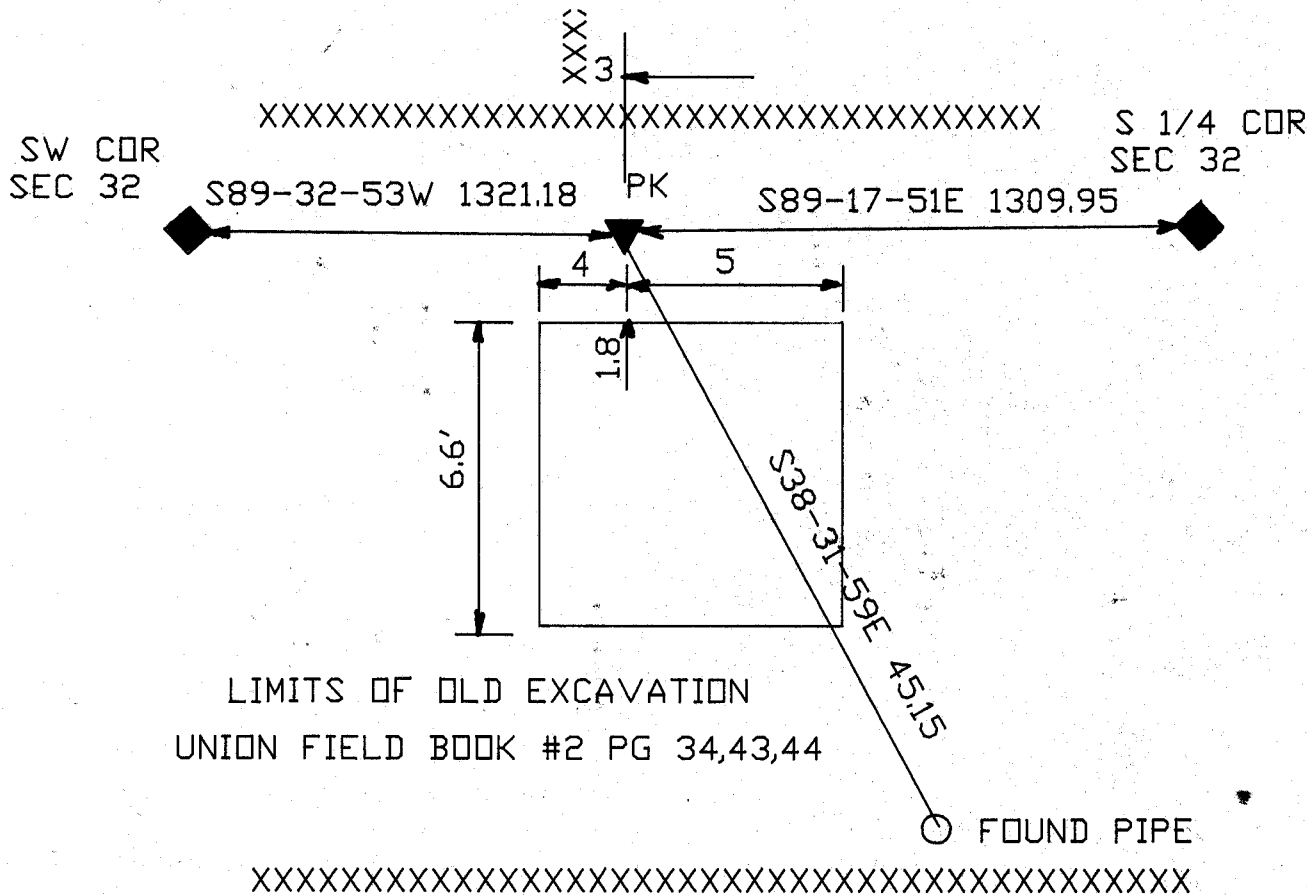

(B) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

1900 BROWN VOL 2 PG 518 PLACED IRON 1317.52 WEST OF THE SOUTH QUARTER CORNER OF SECTION 32 AND ON THE SOUTH LINE OF THE SW 1/4 OF SECTION 32.

1968 BATTERMAN JR. VOL 4 PG 365 FOUND LIMESTONE 1.5' DEEP AND REFERENCED SAME WITH 3 REFERENCE PIPES. CALLS FOR IT AS THE W 1/16 COR SEC 32/5.

DID NOT FIND THE NW AND NE REFERENCE PIPES. FOUND THE SE REFERENCE PIPE (REC 40.16'). ALSO FOUND THE OLD EXCAVATION PATCH. THE PK THAT I PLACED IS 4.7 NORTH OF THE CENTER OF THE PAVEMENT. I DUG 2.8' DEEP AT RECORD DISTANCE FROM THE FOUND REFERENCE PIPE. I STARTED AT THE SW CORNER OF THE PATCH AND DUG A 2' WIDE HOLE UNTIL I WAS 2 NORTH OF THE CENTER OF THE PAVEMENT. I FOUND NOTHING.

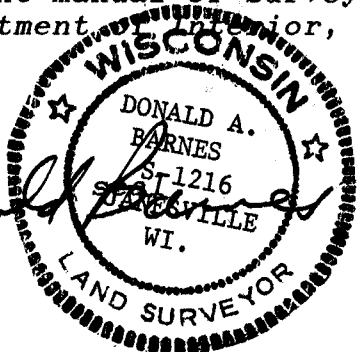
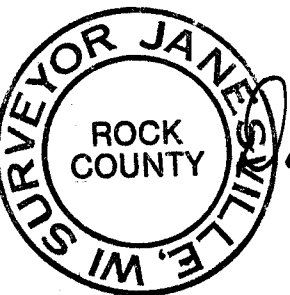
