1. **Call to Order:** Chair Bostwick called the meeting to order at 7:01 pm.

2. **Approval of Agenda:** Supervisor Davis moved to approve the agenda as presented, seconded by Supervisor Aegerter. **Motion Carried.**
3. **Approval of Minutes – March 6, 2019:** Supervisor Quade moved the minutes from the April 3, 2019 LCC meeting, seconded by Supervisor Sweeney. **Motion Carried.**
4. **Citizen Participation, Communications, and Announcements:** Supervisor Aegerter noted the Janesville Farmers Outdoor Market will begin Saturday May 4<sup>th</sup>.
5. **Review Bills Paid:** The committee reviewed the bills paid. Supervisor Davis asked about the bill for Greater Beloit Publishing Co. Tom Sweeney responded it was for a notice of a public hearing regarding issuance of a Non-Metallic Mining Reclamation Permit.
