Rick Wietersen, Public Health Department will discuss this effort and demonstrate how samples are taken from the wells to be tested for nitrate levels. **Depart at 10:30 am.** (45 minutes).
- 3) **Arrive at 10:33 am. New Agricultural Storage Building on County Farm.** Norm Tadt will give a brief introduction to the new building and the LCDs involvement with this project. **Depart at 10:48 am.** (5 minutes).
- 4) **Arrive at 11:05 am. Camp Indian Trails – Big Dam Big Pond (interesting project).** Norm Tadt will introduce the Committee to this project's inception and desired outcome.
