THE RECORD JOB DISTANCES OF 13.99' BETWEEN THE E 1/4

COR SEC 36 & THE W 1/4 COR SEC 31 WAS INCORRECTLY TRANSCRIBED. LOCKE'S DISTANCE IS .21 1/2 CHAINS AND NOT ".212". HIS JOB DISTANCE IS 14.19.

DID NOT PLACE A MONUMENT AT THE W 1/4 COR SEC 31. THIS RECORD IS TO CONSOLIDATE THE ACTIVITIES OF RECORD AND TO CORRECT RECORDS I MADE CONCERNING THE W 1/4 COR OF SEC 31 CENTER TWP AND THE TRANSCRIPTION ERROR OF LOCKE'S RECORD JOB AT THE W 1/4 COR OF SEC 31.

C) Was the corner restored through acceptance of (1) an obliterated evidence location, or, (2) a found perpetuated location?

ACCEPTED THE ALUM. MON. ON TOP OF THE FD SANDSTONE AS THE E 1/4 COR SEC 36 AS PERPETUATED.

D) Describe any material discrepancy between the location of the corner as restored or reestablished and the location of that corner as previously restored or reestablished by distance and direction. Show the discrepancy on the plan view drawing under (a), above. Show the distances between the corner as previously restored or reestablished and (1) the corner as restored or reestablished, and (2) to at least 4 of the witness monuments shown on the drawing in (a), above.

LOCKE DID NOT PLACE THE W 1/4 COR OF SEC 31 MIDWAY BETWEEN THE NW & SW CORNERS OF SEC 31 AS PRESCRIBED BY THE BLM MANUAL. INSTEAD OF HIS JOB OF 14.19' THE DISTANCE SHOULD BE 11.14'. THE DISTANCE BETWEEN THIS LOCATION & THE NW & SW CORNERS OF SEC 31 IS 2659.11. THE W 1/4 COR OF SEC 31 IS ON LINE WITH THE E 1/4 COR SEC 36 AND THE NE COR SEC 36 AT A DISTANCE OF 11.14'.

(E) Was the corner reestablished through lost corner proportionate methods? If so, show the method, including the directions and distances to other public land survey corners used as evidence or used for proportioning the corner location.

THE W 1/4 COR SEC 31 WAS NEVER ESTABLISHED BY THE ORIGINAL GOV. SURVEY. IT SHOULD BE ESTABLISHED MIDWAY BETWEEN THE NW & SW CORNERS OF SEC 31 ON LINE BETWEEN THE E 1/4 COR SEC 36 AND THE NE COR. OF SEC 36 A DISTANCE OF 11.14'.

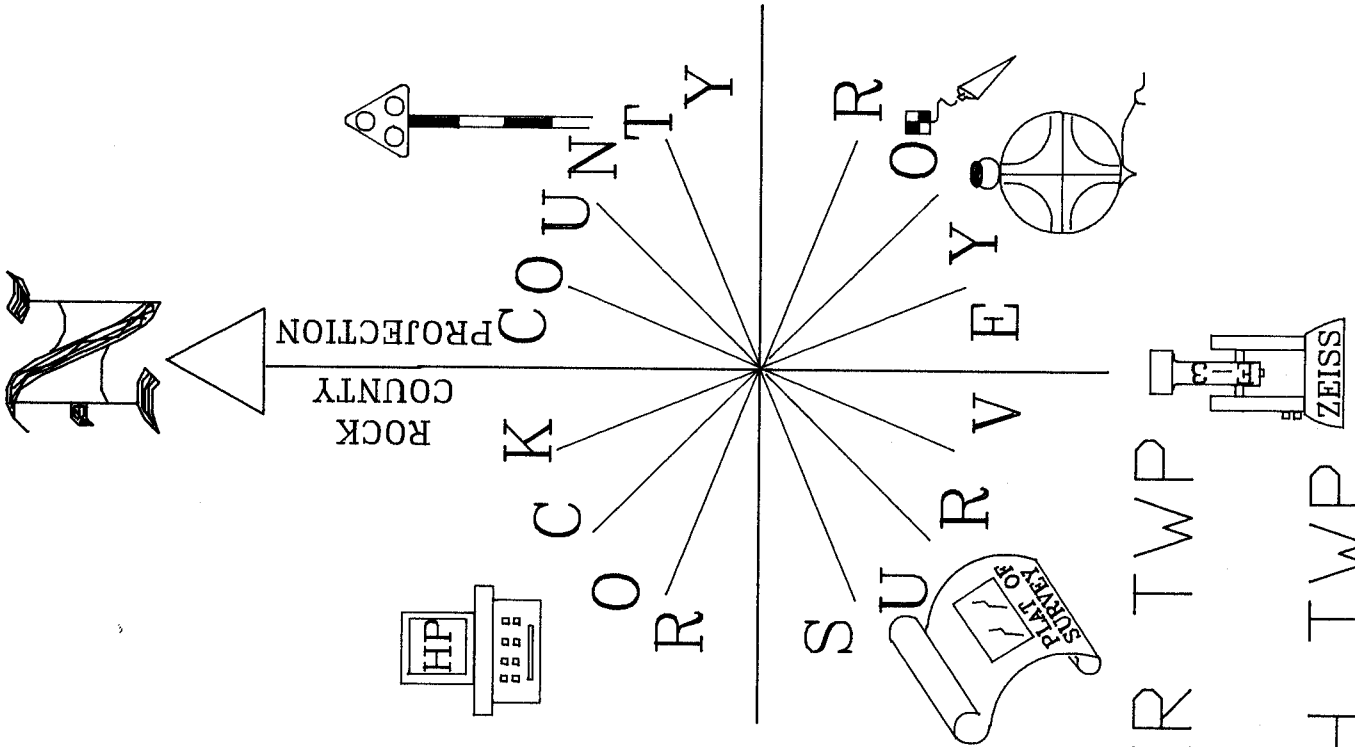
