Health Department Report

COVID Response Update

Katrina Harwood shared a slideshow of the representation of the work that the Health Department is involved in for the county-wide COVID-19 response. For testing, the Health Department is continuing to provide staff support and communications for the Wisconsin National Guard (WING) staffed testing site at Blackhawk Technical College. Statewide, there has been less testing occurring at WING sites and the state Health Department is looking at the future of community-based testing sites throughout the state. Rock County will have WING support until at least May 27th. One of the main components to the response is to complete case investigations and contact tracing for people who have positive test results. Another large component of the response is vaccinations. Vaccine eligibility is open to all Wisconsin residents over the age of 16, beginning on April 2nd. Alison Chouinard from the Rock County Public Health Department is serving as the Vaccine Coordinator and is leading the Vaccine Advisory Committee. There is also a vaccine transportation subcommittee. An MOU has been established with the City of Janesville and vaccines will be available to the homebound population soon through a partnership between Janesville EMS and the Rock County Public Health Department. Planning for COVID-19 vaccine clinics in local schools is underway. The Environmental Health Division continues to provide support to businesses on the mask order and the phased reopening guidance.

The following pieces below go along with the different categories of the COVID-19 response.

Communications: Coordinated by Jessica Turner from the Rock County Public Health Department. Continues to be extremely busy. A weekly media summary is being distributed to all Board Members.

Public Health Orders and Guidance: The current mask mandate is enforced by Rock County and is ongoing through June 30th. Was updated to follow the current guidelines put forth by the CDC. Businesses have been allowed to open up at 75% capacity.

Surveillance: Nick Zupan provided the Board members with the current COVID-19 data.

Public Health Spotlight

10 Essential Public Health Services

- Essential Public Health Service #1
 - Assess and monitor population health status, factors that influence health, and community needs and assets
 - This service includes:
 - Maintaining an ongoing understanding of health in the jurisdiction by collection, monitoring, and analyzing data on health and factors that influence health to identify threats, patterns, and emerging issues, with a particular emphasis on disproportionately affected populations
 - Using data information to determine the root causes of health disparities and inequities
 - Working with the community to understand health status, needs, assets, key influences, and narrative
 - Collaborating and facilitating data sharing with partners, including multi-sector partners
 - Using innovative technologies, data collection methods, and data sets
 - Utilizing various methods and technology to interpret and communicate data to diverse audiences
 - Analyzing and using disaggregated data (e.g., by race) to track issues and inform equitable action
 - Engaging community members as experts and key partners
 - Examples from our work:
 - Community Health Assessment
 - COVID-19 Data/Surveillance
- Essential Public Health Service #2
 - Investigate, diagnose, and address health problems and hazards affecting the population
 - This service includes:
 - Anticipating, preventing, and mitigating emerging health threats through epidemiologic identification
 - Monitoring real-time health status and identifying patterns to develop strategies to address chronic diseases and injuries
 - Using real-time data to identify and respond to acute outbreaks, emergencies, and other health hazards
 - Using public health laboratory capabilities and modern technology to conduct rapid screening and high-volume testing
 - Analyzing and utilizing inputs from multiple sectors and sources to consider social, economic, and environmental root causes of health status
 - Identifying, analyzing, and distributing information from new, big, and real-time data sources
 - Examples from our work:
 - Licensed establishment inspections
 - Lab (conducting rapid screening and testing)
 - Lead program
 - Communicable disease investigation
