- A. Depart Land Conservation Department Office Building at 9:30 am**
 - B. Arrive at 9:40 am. Waterman Estates Subdivision.** Section 3, Harmony. Observe a recent storm water management maintenance project conducted by the Town to alleviate localized flooding concerns. The development was completed prior to the adoption of the County Storm Water Management Ordinance, but LCD provide technical assistance to the Town in the design of the solution. Highlight cooperation with other municipalities in the County as a whole. **Depart at 9:55 am.**
 - C. Arrive at 10:00 am. Fertilizer Dealer Supply.** Section 36, Milton. Discuss Construction Site Erosion Control and Storm Water Management Ordinance requirements at newly developed commercial property. **Depart at 10:15 am.**
 - D. Arrive at 10:30 am. Rock Prairie Dairy.** Section 2, Bradford. Tour the facility and review the LCD involvement at the site during construction and ongoing. **Depart at 11:30 pm.**
 - E. Lunch Break. Carver-Roehl County Park,** Section 27, Bradford. **Depart 12:15 pm.**
 - F. Arrive at 12:20 pm. Minkey Farm.** Section 27, Bradford. Discuss conservation planning process in general and view challenges at this particular farm. **Depart at 1:10 pm.**
 - G. Arrive at 1:11 pm. Braukhoff Farm.** Section 26, Bradford. View former dairy operation where manure storage facilities have been properly abandoned. Property also has an active quarry and we will discuss nonmetallic mine reclamation and challenges involved. **Depart at 1:30 pm.**
