Providing Alcohol to Anyone Under 21 State Law & Ordinance Violations

People who care about young adults are aware of the serious problems caused by underage alcohol use. Are you?

If you are 17 or older and you provide alcohol to anyone under 21, you can be charged with a crime and your name publicized.

State Statute Violations

If you obtain, sell or give away any alcohol drinks to anyone under 21 you may be fined:

- 1st violation up to \$ 739.00
- 4th violation up to \$1,359.00

If you knowingly allow or fail to prevent drinking of alcohol by anyone under 21 on your property or property under your control, you may be fined:

- 1st violation up to \$ 739.00
- 4th violation up to \$1,359.00

For more detail, Ref. SS 125.07 (1) (a) 3

You may be fined if you encourage or help anyone under 21 do any of the following:

1. Try to obtain alcohol from a bar or other place with a license or permit to sell alcohol drinks.
2. Consume or possess alcohol at a bar or other place licensed to serve alcohol unless with parent, guardian or spouse who is at least 21.
3. Knowingly enters a bar or licensed premises and remain at the bar.
4. Possess a fake ID or lies about his or her age to obtain an alcoholic beverage from a bar or other place with a license or permit to sell alcohol.

- 1st violation up to \$ 739.00
- 4th violation up to \$1,359.00

If you, as an underage person, are arrested for a non-driving alcohol violation, there are certain penalties that apply. Most convictions will result in monetary fines along with a suspension of driving privileges. However, there is a possibility that the penalties can be reduced if you successfully complete the optional program as described in this brochure. The goal of this program is to provide help to the person arrested by having their alcohol use or abuse evaluated by a certified drug and alcohol counselor with one of the listed community agencies.

The District Attorney's Office, Rock County Law Enforcement, Rock County Schools and Alcohol and Drug Abuse Agencies have partnered to provide this important program opportunity for you.

Program Procedures

Please note the following steps:

Within three (3) working days after the issuance of your citation, you MUST:

1. a) If you are enrolled in a school within Rock County and the violation occurs during the school year, you are required to contact the school-AODA Coordinator listed on the back for further information on the program. b) If you are not enrolled in a Rock County school or, the violation occurs during summer vacation proceed to step 2.
2. Make an appointment for an alcohol assessment before your court date with one of the agencies listed on the back.
3. Attend your alcohol assessment interview (before your court date). **You must appear with a parent and your citation in order to be in compliance** or the assessment cannot be completed.
4. Appear in court on your scheduled date. Bring along the written assessment confirmation, which will indicate any follow-up recommendations. If you are under 17, your parent must accompany you to this and all court appearances. If any follow-up work is required, another court date will be set, based on the expected completion date.
5. Complete the follow-up recommendations within 90 days of your initial court date. Remember, appear in court on your continued date. Bring along the written compliance report that states you have successfully completed the recommendations. If you are under 17, your parents must accompany you.
7. The Rock County District Attorney's Office requires education programming as a minimum for follow-up to be in compliance for an underage alcohol violation.

1	Conviction, but no other penalty	\$248.00 fine, 90 day suspension
2, but first in 12 months	Discretionary by D.A.'s Office	\$248.00 fine, 90 day suspension
2 nd within 12 months	Discretionary by D.A.'s Office	\$373.00 fine, 1 year suspension
3 rd within 12 months	Discretionary by D.A.'s Office	\$498.00 fine, 1 year suspension
4 th within 12 months	Discretionary by D.A.'s Office	\$748.00 fine, 1 year suspension

PLEASE NOTE: These are recommended penalties only. The Assistant District Attorney or the Judge may request different penalties if warranted by the circumstances of the individual case. **If the person arrested for underage drinking is either the driver of a vehicle or the passenger in a vehicle when arrested, there will be a mandatory 30-day driver's license suspension even for a first offense where the juvenile completes the program.** If there is a suspension of your driver's license, the Department of Transportation does require a reinstatement fee.
